**EMERGENCY OVERVIEW:** Not available.

**Potential Health Effects:**

**Eye:** May cause eye irritation.

**Skin:** May cause skin irritation. Causes a burning sensation on contact with the skin.

**Ingestion:** May cause irritation of the digestive tract. The toxicological properties of this substance have not been fully investigated.

**Inhalation:** May cause respiratory tract irritation. The toxicological properties of this substance have not been fully investigated. Methylene chloride is metabolized to carbon monoxide. Overexposure may cause an increase in carboxyhemoglobin levels in blood. Persons with a compromised cardiovascular system may not be able to tolerate the added cardiovascular stress.

**Chronic:** Not available. Possible cancer hazard based on tests with laboratory animals. Lung, liver and pancreatic tumors have been associated with chronic exposure to methylene chloride. Animals studies with rats and mice have shown delayed ossification of sternobrae and an increased incidence of extra sternobrae when exposed by inhalation.

#### Section 4: First Aid Measures

**Eyes:** Flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid.

**Skin:** Get medical aid. Flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes.

**Ingestion:** Get medical aid. Wash mouth out with water.

**Inhalation:** Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid.

**Notes to Physician:** Treat symptomatically and supportively.
