### Section 3: Hazards Identification

**EMERGENCY OVERVIEW:** Appearance: light yellow powder. Hygroscopic (absorbs moisture from the air). Light sensitive.

**Warning!:** Causes eye and skin irritation. May cause digestive tract irritation. Causes respiratory tract irritation. Irritant. Harmful if swallowed, inhaled, or absorbed through the skin.

**Target Organs:** Respiratory system, eyes, skin.

**Eye:** Causes eye irritation. May cause chemical conjunctivitis.

## Section 4: First Aid Measures

**Eyes:** Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid.
