## Section 7: Handling and Storage

**Precautions:**

Do not breathe dust. In case of insufficient ventilation, wear suitable respiratory equipment. If you feel unwell, seek medical attention and show the label when possible. Avoid contact with skin and eyes. Keep away from incompatibles such as reducing agents.
