Storage:

Air sensitive. Moisture sensitive Keep container in a cool, well-ventilated area. Keep container tightly closed and sealed until ready for use. Avoid all possible sources of ignition (spark or flame). Refrigerate. Do not store above 4°C (39.2°F).
