Section 4: First Aid Measures

Eye Contact:

Slightly flammable to flammable in presence of heat. Non-flammable in presence of shocks.

Fire Fighting Media and Instructions:

SMALL FIRE: Use DRY chemical powder. LARGE FIRE: Use water spray, fog or foam. Do not use water jet.

Special Remarks on Fire Hazards:

When heated to decomposition it emits very toxic fumes of hydrogen fluoride, and nitroxides. As with most organic solids, fire is possible at elevated temperatures.

Special Remarks on Explosion Hazards:

Fine dust dispersed in air in sufficient concentrations, and in the presence of an ignition source is a potential dust explosion hazard.

Section 6: Accidental Release Measures

Small Spill:

Use appropriate tools to put the spilled solid in a convenient waste disposal container. Finish cleaning by spreading water on the contaminated surface and dispose of according to local and regional authority requirements.

Large Spill:
