After contact with skin, wash immediately with plenty of water. Gently and thoroughly wash the contaminated skin with running water and non-abrasive soap. Since the product can readily penetrate the protective epidermal layer and cause rashes or eczema, a good hand cream should be used after washing affected areas. Seek medical attention. Wash contaminated clothing before reusing.
