Section 3: Hazards Identification

Potential Acute Health Effects:

Very hazardous in case of eye contact (irritant), of ingestion. Hazardous in case of skin contact (irritant, permeator), of inhalation. Inflammation of the eye is characterized by redness, watering, and itching.

Section 4: First Aid Measures

Eye Contact:
