### Section 3: Hazards Identification

**Potential Acute Health Effects:**

Hazardous in case of skin contact (irritant), of eye contact (irritant), of ingestion, of inhalation (lung irritant, lung corrosive). Severe over-exposure can result in death.

**Potential Chronic Health Effects:**

**Eye Contact:**

**Small Spill:**

### Precautions:

Keep locked up.. Keep away from heat. Keep away from sources of ignition. Empty containers pose a fire risk, evaporate the residue under a fume hood. Ground all equipment containing material. Do not ingest. Do not breathe dust. Wear suitable protective clothing. If ingested, seek medical advice immediately and show the container or the label. Avoid contact with skin and eyes. Keep away from incompatibles such as oxidizing agents, acids.

### Storage:

Sensitive to light. May discolor on exposure to light. Store in light resistant containers. Keep container tightly closed. Keep container in a cool, well-ventilated area. Do not store above 25°C (77°F).
