Fine dust dispersed in air in sufficient concentrations, and in the presences of an ignition source is a potential dust explosion hazard.

## Section 6: Accidental Release Measures

**Small Spill:**

Avoid dust formation. Spilled material may cause a slipping hazard. Use appropriate tools to put the spilled solid in a convenient waste disposal container. Finish cleaning by spreading water on the contaminated surface and dispose of according to local and regional authority requirements.

**Large Spill:**

Ventilate area. Avoid dust formation. Spilled material may cause a slipping hazard. Clean up spills immediately. Use a shovel to put the material into a convenient waste disposal container. Finish cleaning by spreading water on the contaminated surface and allow to evacuate through the sanitary system. Be careful that the product is not present at a concentration level above TLV. Check TLV on the MSDS and with local authorities.

## Section 7: Handling and Storage

### Precautions:

Good housekeeping and controlling of dusts are necessary for safe handling of product. Keep away from heat. Keep away from sources of ignition. Empty containers pose a fire risk, evaporate the residue under a fume hood. Ground all equipment containing material. Do not ingest. Do not breathe dust. If ingested, seek medical advice immediately and show the container or the label. Keep away from incompatibles such as oxidizing agents, acids, alkalis.

### Storage:

Keep container tightly closed. Keep container in a cool, well-ventilated area. Do not store above 32 deg. C (90 deg. F).
