Section 4: First Aid Measures

Eye Contact:

Section 6: Accidental Release Measures

Small Spill:

Use appropriate tools to put the spilled solid in a convenient waste disposal container. Finish cleaning by spreading water on the contaminated surface and dispose of according to local and regional authority requirements.

Large Spill:

Use a shovel to put the material into a convenient waste disposal container. Finish cleaning by spreading water on the contaminated surface and allow to evacuate through the sanitary system.

Section 7: Handling and Storage

Precautions:

Keep container dry. Keep away from heat. Keep away from sources of ignition. Empty containers pose a fire risk, evaporate the residue under a fume hood. Ground all equipment containing material. Do not ingest. Do not breathe dust. Never add water to this product. In case of insufficient ventilation, wear suitable respiratory equipment. If ingested, seek medical advice immediately and show the container or the label. Avoid contact with skin and eyes. Keep away from incompatibles such as oxidizing agents, acids, alkalis.

Storage: Keep container tightly closed. Keep container in a cool, well-ventilated area.

Acute Potential Health Effects: Skin: Causes skin irritation/inflammation and possible skin lesions/ulcerations and burns. Skin lesions begin with cracking of the skin and the formation of slow-healing ulcers. It may be harmful if absorbed through the skin. Eyes: Causes eye irritation and possible eye/corneal injury/burns. Symptoms may include blurred vision, redness, pain and possibly severe tissue burns Inhalation: Causes irritation of the respiratory tract, mucous membranes, and lungs, ulceration of the mucous membranes. Exposure can cause coughing, spasm, inflammation and edema of the larynx, and bronchi, chemical pneumonitis, pulmonary edema, chest pains, burning sensation, wheezing, and difficulty in breathing. Inhalation can cause systemic poisoning Ingestion: May be harmful if ingested. Causes digestive irritation and possible burns. Symptoms may include ulceration of the mouth, headache, nausea, vomiting, diarrhea, excess salivation. May affect behavior/central nervous system (lethargy, ataxia, nervousness, weakness, muscle tremors, convulsions, staggering, depression). cardiovascular system (rapid weak pulse, hypotension, dysrhythmia), respiration(rapid labored respiration), kidneys/urinary system (shrunken fibrotic kidneys, and anuria, proteinuria, albuminuria, hematuria, nephrosis from kidney damage). Other symptom may include low blood calcium levels (hypocalcemia). Chronic Potential Health Effects: Ingestion: Prolonged or repeated ingestion can cause kidney damage, emaciation due to poor appetite, and anemia and can affect behavior/central nervous system Eyes: Prolonged contact may cause eye damage. Skin: Prolonged or repeated skin contact may cause dermatitis.
