Cobalt is listed by IARC as a Group 2A (possible human) carcinogen. However, Cobalt Chloride is not included on the IARC human carcinogens list.

Special Remarks on other Toxic Effects on Humans:

Acute Potential Health Effects for the Product: Skin: May cause irritation with dryness of the skin in cases of severe exposure
Eyes: No adverse effects expected, but dust may cause mechanical irritation. Inhalation: May cause dryness and irritation to mucous membranes and respiratory tract in case of severe exposure. Ingestion: May be harmful if swallowed in large amounts. However, no adverse effects are expected for normal industrial handling. Silica gel is a synthetic amorphous silica, not to be confused with crystalline silica such as quartz, cristobalite, or tridymite or with diatomaceous earth or other naturally occurring forms of amorphous silica that frequently contain crystalline forms. Epidemiological studies indicate a low potential for health effects. Cobalt Chloride can cause dermatitis and irritation of the nasal passages and lungs.
