Acute Potential Health Effects: Skin: May cause skin irritation. Eyes: May cause eye irritation. Inhalation: May cause respiratory tract irritation. Ingestion: No information found for Sulfachloropyridazine. However, toxicity information for Sulfamethoxyypyridazine and for Sulfamides was used to determine some possible health/toxicological effects of Sulfchloropyridazine. Ingestion of suflamides can cause nausea, vomiting, diarrhea, anorexia, photosensitization, allergic reaction. Ingestion of sulfamides may also affect the liver (hepatitis), kidneys (tubular necrosis, interstitial tubular neuropathy), and the blood (Thrombocytopenia, Leukopenia, Agranulocytosis, Eosinophilia). Ingestion of Sulfamides may also rarely cause Lyell Syndrome, and Stevens-Johnson Syndrome. Chronic Potential Health Effects: Prolonged or repeated exposure may affect the blood and kidneys. The toxicological properties of this substance have not been fully investigated.
