#### Section 3: Hazards Identification

**Potential Acute Health Effects:**

Extremely hazardous in case of eye contact (irritant). Very hazardous in case of skin contact (irritant), of ingestion, . Hazardous in case of skin contact (permeator), of inhalation (lung irritant).
