Section 3: Hazards Identification

Potential Acute Health Effects:

Hazardous in case of ingestion, of inhalation. Slightly hazardous in case of skin contact (corrosive, irritant, permeator), of eye contact (irritant). Liquid or spray mist may produce tissue damage particularly on mucous membranes of eyes, mouth and respiratory tract. Skin contact may produce burns. Inhalation of the spray mist may produce severe irritation of respiratory tract, characterized by coughing, choking, or shortness of breath.

Potential Chronic Health Effects:

Slightly hazardous in case of eye contact (irritant), of ingestion, of inhalation. Non-corrosive for skin. Non-irritant for skin. Non-sensitizer for skin. CARCINOGENIC EFFECTS: Not available. MUTAGENIC EFFECTS: Not available. TERATOGENIC EFFECTS: Not available. DEVELOPMENTAL TOXICITY: Not available. The substance is toxic to lungs, mucous membranes. Be particularly careful to clean folds, crevices, creases and groin. Cold water may be used. Cover the irritated skin with an emollient. If irritation persists, seek medical attention.

Small Spill:

Dilute with water and mop up, or absorb with an inert dry material and place in an appropriate waste disposal container. If necessary: Neutralize the residue with a dilute solution of sodium carbonate.

Large Spill:

Corrosive liquid. Stop leak if without risk. Absorb with DRY earth, sand or other non-combustible material. Do not get water inside container. Do not touch spilled material. Use water spray curtain to divert vapor drift. Prevent entry into sewers, basements or confined areas; dike if needed. Call for assistance on disposal. Neutralize the residue with a dilute solution of sodium carbonate. Be careful that the product is not present at a concentration level above TLV. Check TLV on the MSDS and with local authorities.

Precautions:

Keep container dry. Do not ingest. Do not breathe gas/fumes/ vapour/spray. Avoid contact with skin Never add water to this product Wear suitable protective clothing In case of insufficient ventilation, wear suitable respiratory equipment If ingested, seek medical advice immediately and show the container or the label. May corrode metallic surfaces. Store in a metallic or coated fiberboard drum using a strong polyethylene inner package.
