## Section 6: Accidental Release Measures

**Small Spill:**

Dilute with water and mop up, or absorb with an inert dry material and place in an appropriate waste disposal container. Finish cleaning by spreading water on the contaminated surface and dispose of according to local and regional authority requirements.

**Large Spill:**

Absorb with an inert material and put the spilled material in an appropriate waste disposal. Finish cleaning by spreading water on the contaminated surface and allow to evacuate through the sanitary system. Be careful that the product is not present at a concentration level above TLV. Check TLV on the MSDS and with local authorities.

Keep locked up.. Keep container dry. Do not ingest. Do not breathe gas/fumes/ vapor/spray. Never add water to this product. If ingested, seek medical advice immediately and show the container or the label. Avoid contact with skin and eyes.

Acute Potential Health Effects: Skin: May cause skin irritation. Eyes: May cause eye irritation. Inhalation: May cause respiratory tract, nasal, and mucous membrane irritation. May affect behavior, and metabolism. Ingestion: May cause irritation of mouth and digestive tract with nausea, vomiting and diarrhea. May also affect behavior, the urinary system and cardiovascular system. Chronic Potential Health Effects: Ingestion: May cause a reversible reduction in thyroid function, metabolic disturbances, and may affect the blood (anemia). Symptoms of chronic iodine poisoning may include rapid heartbeat, tremor, weight loss, diarrhea, insomnia, eye irritation, bronchitis, gastric irritation, and skin rash.(Iodine) Chronic Potential Health Effects: Can lead to iodism characterized by salivation, nasal discharge, sneezing, conjunctivitis, fever, laryngitis, bronchitis, stomatitis, and skin rashes. Chronic ingestion of iodides (in animals) during pregnancy has resulted in fetal deaths, severe goiter and cretinoid appearance of the newborn. (Potassium Iodide)
