Section 4: First Aid Measures

Eye Contact:

Section 6: Accidental Release Measures

Small Spill:

Use appropriate tools to put the spilled solid in a convenient waste disposal container. Finish cleaning by spreading water on the contaminated surface and dispose of according to local and regional authority requirements.

Large Spill:

Use a shovel to put the material into a convenient waste disposal container. Finish cleaning by spreading water on the contaminated surface and allow to evacuate through the sanitary system.

Precautions:

Keep away from heat. Keep away from sources of ignition. Ground all equipment containing material. Do not ingest. Do not breathe dust. Wear suitable protective clothing. If ingested, seek medical advice immediately and show the container or the label. Keep away from incompatibles such as oxidizing agents, alkalis.

Keep container tightly closed. Keep container in a cool, well-ventilated area. Sensitive to light. Store in light-resistant containers.

Special Remarks on Chronic Effects on Humans:

May cause adverse reproductive effects based on animal data after animals had been given oral doses. No human studies have been found relating oral dosage and reproductive effects. In humans, Miconazole has typically been used topically and intravaginally in the treatment of vulvovaginal candidiasis and other fungal infections. A variety of clinical studies have not detected and increase in congenital malformations when it has been used in this manner by pregnant women. Although the report on the most recent study did not identify an increased risk for birth defects as a group or specifically for oral clefts, spina bifida, or cardiovascular defects, the analyzed data were not sufficient to rule out possible associations with other specific defects.

Special Remarks on other Toxic Effects on Humans:

Acute Potential Health Effects: Skin: May cause skin irritation. There is little absorption through the skin. Inhalation: May cause respiratory tract irritation. Ingestion: May be harmful if swallowed. May cause gastrointestinal tract irritation with diarrhea. It may cause ulceration or bleeding from the stomach. May affect behavior/central nervous system (ataxia). Chronic Potential Health Effects: Possible allergic reaction to material if inhaled, ingested or in contact with skin. Prolonged or repeated ingestion may affect the liver, blood (changes in blood cell count). Medical Conditions Aggravated by Exposure: Hypersensitivity to material, acute porphyria, and impaired liver function.
