It related to Tetracycline. Therefore, it may cause adverse reproductive effects and birth defects (teratogenic) and may also affect genetic material (mutagenic).

Special Remarks on other Toxic Effects on Humans:

Acute Potential Health Effects: Skin: May cause skin irritation. Eyes: May cause eye irritation. Inhalation: May cause respiratory tract irritation. Symptoms may include nasal itching, sneezing Ingestion: It may cause nausea, vomiting, hypermotility, diarrhea. It may also cause photosensitivity when exposed to direct sunlight or UV light. It may affect respiration (dyspnea), blood (agranulocytosis, leukocytosis, atypical lymphocytes, normocytic anemia, thrombocytopenia), musculoskeletal system (joints), and spleen. It may also cause allergic skin reaction (dermatitis) which may be aggravated by exposure to direct sunlight or UV light. Also, it is related to Tetracycline therefore it may have other effects similar to Tetracycline. Tetracycline may affect behavior (somnolence), metabolism (metabolic acidosis), liver (impaired liver function, jaundice), and urinary system (transient renal impairment, hemoglobinuria). Chronic Potential Health Effects: Ingestion: Prolonged or repeated ingestion may have symptoms similar to acute ingestion. Skin: Possible allergic reaction. Inhalation: Possible allergic reaction.
