Section 3: Hazards Identification

Potential Acute Health Effects:

Very hazardous in case of ingestion, of inhalation. Hazardous in case of skin contact (permeator), of eye contact (irritant). Slightly hazardous in case of skin contact (irritant). Severe over-exposure can result in death.

Potential Chronic Health Effects:
