Section 3: Hazards Identification

Potential Acute Health Effects:

Very hazardous in case of inhalation. Hazardous in case of skin contact (irritant), of eye contact (irritant). Slightly hazardous in case of skin contact (sensitizer, permeator), of ingestion. Severe over-exposure can result in death.

Eye Contact:
