Section 4: First Aid Measures

Eye Contact:

Small Spill:

Use appropriate tools to put the spilled solid in a convenient waste disposal container. Finish cleaning by spreading water on the contaminated surface and dispose of according to local and regional authority requirements.

Use a shovel to put the material into a convenient waste disposal container. Finish cleaning by spreading water on the contaminated surface and allow to evacuate through the sanitary system.

Precautions:

Keep locked up.. Keep away from heat. Keep away from sources of ignition. Do not ingest. Do not breathe dust. Avoid contact with eyes. Wear suitable protective clothing. In case of insufficient ventilation, wear suitable respiratory equipment. If ingested, seek medical advice immediately and show the container or the label. Keep away from incompatibles such as oxidizing agents.

Storage:

Keep container tightly closed. Keep container in a cool, well-ventilated area. Although it is stable at room temperature, it is preferable to store it between 0 to 5 degrees C in order to reduce deterioration.
